## RESCISSION OF NOTICE OF DEFAULT

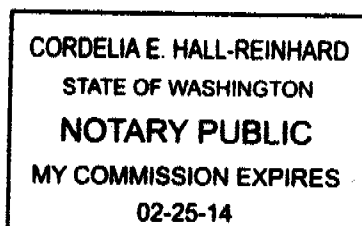
