QUITCLAIM DEED

KNOW ALL BY THESE PRESENTS that Anthony W. Hunsinger

hereinafter called grantor, for the consideration hereinafter stated, does hereby remise, release and forever quitclaim unto

Christina L. Hunsinger

hereinafter called grantee, and unto grantee's heirs, successors and assigns, all of the grantor's right, title and interest in that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or in any way appertaining, situated in Klamath County, State of Oregon, described as follows, to-wit:

Beginning at a point on the East line of Lot 6, VICTORY ACRES, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon, 100 feet South of the Northeast corner of said lot, said point of beginning being on the West line of Logan Street, 100 feet South of its intersection with the South line of Ghasta Way; thence West parallel to the North line of lot 6, 100 feet; thence South parallel to the West line of Lot 6, 75 feet; thence East parallel to the North line of lot 6, 100 feet to the West line of Logan Street; thence North to the point of beginning.

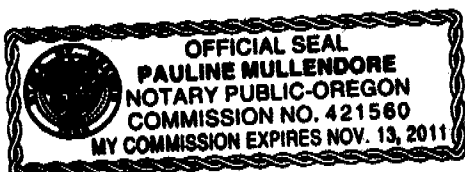
