Third parties without actual notice of revocation may conclusively rely on the continued validity of this power of attorney. My Attorney-in-Fact may sue or pursue other action against any third party who refuses to honor this power of attorney.

This power shall become effective immediately upon signing of this document.

The powers granted to my Attorney-in-Fact under this power of attorney shall continue to be exercisable even though I have become disabled or incompetent.

My said Attorney-in-Fact and all persons unto whom these presents shall come may assume that this power of attorney has not been revoked until given actual notice either of such revocation or of my death.
