EVANS and JEANNETTE EVANS, AS TENANTS BY THE ENTIRETY, hereinafter called grantee, and unto grantee's heirs, successors and assigns all of that certain real property with the tenements, hereditaments and appurtenances thereunto belonging or in anyway appertaining, situated in the County of **KLAMATH**, State of Oregon, described as follows, to wit:

Lots 1, 2, 7 and 8 in Block 1, HOYTS ADDITION TO FORT KLAMATH, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon.

TOGETHER WITH that portion of vacated alley as vacated by County Commissioners Order 92-268, recorded June 5, 1992 in Volume M92, Page 12271, and that portion of vacated Taylor Street vacated by Order 2003-105, recorded May 21, 2003 in Volume M03, page 34307, as inured thereto.

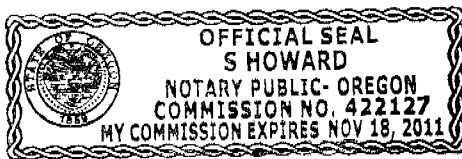
