AMENDMENT TO DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS FOR REGENCY 3 SUBDIVISION

WHEREAS, Skies the Limit, Inc., Declarant, filed a Declaration of Conditions and Restricts relating to a plat designated as Regency Estates Phase 3 Subdivision, Tract 1445, located in the North 1/2, Section 14, Township 39 South, Range 9 East of the Willamette Meridian, Klamath County, OR;

WHEREAS, the undersigned, being a seventy-five percent majority of property owners within Regency Estates Phase 3 wish to modify a portion of those Declarations;

NOW, THEREFORE, the parties hereto agree that Article 4.5 of the CONDITIONS, COVENANTS & RESTRICTIONS shall be amended to read:

4.5 <u>CONSTRUCTION</u>: ... Each Dwelling shall have lap siding, unless otherwise approved by the Architectural Control Committee. Tarpaper, roll brick, sheet aluminum, and masonry block shall not be permitted on a Dwelling. T1-11 siding shall be permitted on the 3 inferior sides; the front of Dwelling shall contain lap siding or a comparable material...

The remainder of the Declaration shall continue without change.
