**NOTICE OF DEFAULT AND ELECTION TO SELL**

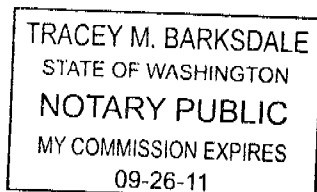
