Lot 5, VALE HEIGHTS, TRACT 1386, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon.

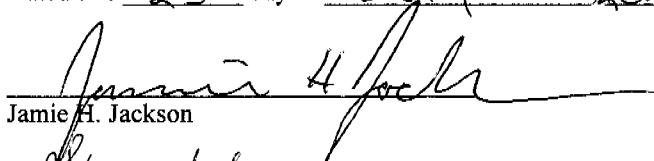
