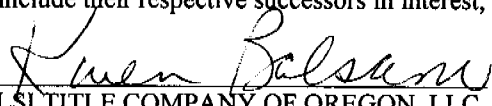

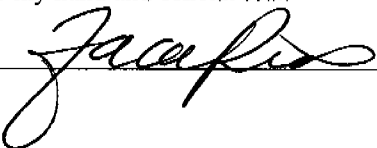

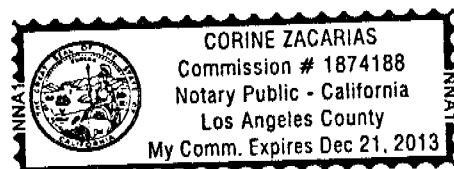

EXHIBIT "A" LEGAL DESCRIPTION

PARCEL 1:
