have made, constituted and appointed, and by these presents do hereby make, constitute and appoint

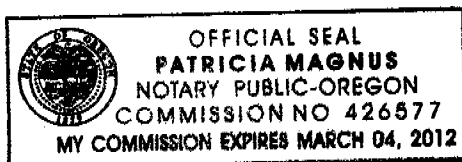
