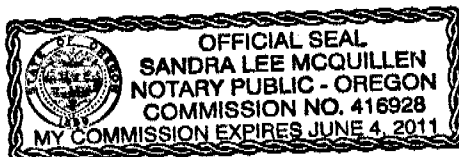
NOTICE OF PENDENCY OF ACTION
