



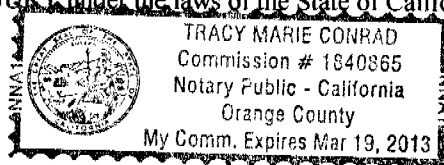

NOTICE TO TENANTS
