EXHIBIT "A" LEGAL DESCRIPTION

PARCEL 1:

Lot 3 in Block 47 of HOT SPRINGS ADDITION to Klamath Falls, Oregon, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon.
