ARTICLES OF INCORPORATION

OF THE

CRESCENT WATER SUPPLY AND IMPROVEMENT DISTRICT

The undersigned, natural persons of the age of eighteen (18) years or more, acting as incorporators under the provisions of Chapter 554 of Oregon Revised Statutes and being the owners of the land described below, adopt the following Articles of Incorporation.

ARTICLE I

The name of this corporation is **Crescent Water Supply and Improvement District**, and its duration shall be perpetual.

ARTICLE II

The purpose or purposes for which the corporation is organized is to construct and maintain a domestic water supply and distribution system to serve the property described in these Articles.

ARTICLE III

The corporation is organized as a nonprofit corporation and is not organized for profit to the corporation or its members other than the benefits accruing from the improvements to the property described in this Articles.

ARTICLE IV

- (1) The proposed district is for provision of domestic water services to the properties described in the Articles of Incorporation.
- (2) The formation of a corporate district under the provisions of ORS 554.005 to 554.340 is a proper and advantageous method of accomplishing the improvement and protection of the lands described in these Articles.

(3) All revenue and income of the corporation, from whatsoever source, shall be received, held, used and expended exclusively for the payment of expenses of the services and improvements.

(4) Neither the corporation nor its members shall profit from the business of the corporation other than from the benefits of improvement of the land for which the corporation is formed.

(5) It is the intention and desire of all the persons owning and having any interest in any of the lands described in these Articles to organize such corporation as a public corporation of Oregon under the provisions of ORS 554.005 to 554.340 with the rights and privileges of a public corporation, by the unanimous voluntary consent of all persons.

ARTICLE V

The address of the initial registered office and principal office of the corporation is 136101 Hwy 97 N., Crescent, Oregon 97733, and the name of its initial registered agent at such address is Karen Ishida-Poncil.

ARTICLE VI

The number of directors constituting the initial Board of Directors of the corporation is five (5), and the names and addresses of the persons who are to serve as directors until the first annual meeting of the members or until their successors are elected and shall qualify:
