EXHIBIT "A"
LEGAL DESCRIPTION

The following described real property in Klamath County, Oregon:

A parcel of land lying in the East 1/2 of SW1/4 of Section 1, Township 39 South, Range 9 East of the Willamette Meridian, described as follows:

Beginning at an iron pin which lies North 0°51' West along the 40 line a distance of 462.3 feet and North 89°09' East a distance of 262.2 feet and South 46°09' East a distance of 657.8 feet from the iron axle which marks the Southwest corner of the NE1/4 SW1/4 of Section 1; and running thence continuing South 46°09' East a distance of 352.1 feet to an iron pin which lies on the Northwesterly right of way line of the Enterprise Irrigation Canal; thence North 11°21' East along the Northwesterly right of way line of the Enterprise Canal a distance of 337.4 feet to an iron pin; thence continuing along the Northwesterly right of way line of the Enterprise Irrigation Canal North 60°21' East a distance of 103.3 feet to an iron pin on the Klamath Falls-Lakeview Highway Southerly right of way line of 30 feet at right angles from its center; thence North 46°09' West along the above mentioned highway right of way line a distance of 200 feet to an iron pin; thence South 43°51' West a distance of 384 feet more or less to the Point of Beginning.
