Modification NOTICE OF ADVANCE UNDER DEED OF TRUST

WHEREAS Scott L. Runels, also known as and who acquired title as Scott Lee Runels and Margie B. Runels, husband and wife are named as grantor/trustor (hereinafter "Grantor") in that certain deed of trust dated March 15, 2004 wherein First American Title Insurance Company of Oregon, is named as trustee and Farm Credit West, FLCA, is named as beneficiary, which instrument was recorded March 29, 2004, as Volume MO4, Page 17473-17487, Klamath County, State of Oregon;

AND WHEREAS the said deed of trust was given to secure the payment of promissory notes in the aggregate amount of \$2,313,053.00, of various dates, and other obligations of the grantor recited therein, evidenced on the books of Farm Credit West, FLCA, as Loan No's 3709655, and 8285314/0005326184;
