
**SUBSTITUTION OF TRUSTEE and FULL RECONVEYANCE**



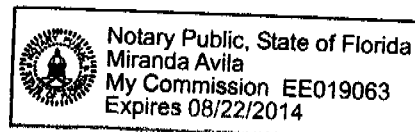

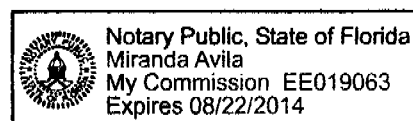
