EVANS AND JEANNETTE EVANS, TRUSTEES OF THE BOB AND JEANNETTE EVANS FAMILY TRUST, DATED 15, 2002,
hereinafter called grantee, and unto grantee's heirs, successors and assigns, all of that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or in any way appertaining, situated in KLAMATH County, State of Oregon, described as follows, to-wit:

LOTS 1, 2, 7, AND 8, IN BLOCK 1, HOYT'S ADDITION TO FORT KLAMATH, ACCORDING TO THE OFFICIAL PLAT THEREOF ON FILE IN THE OFFICE OF THE COUNTY CLERK OF KLAMATH COUNTY, OREGON.

TOGETHER WITH THAT PORTION OF VACATED ALLEY AS VACATED BY COUNTY COMMISSIONERS ORDER 92-268, RECORDED JUNE 5, 1992, IN VOLUME M92, PAGE 12271, AND THAT PORTION OF VACATED TAYLOR STREET VACATED BY ORDER 2003-105, RECORDED MAY 21, 2003, IN VOLUME M03, PAGE 34307, AS INCURED THERE TO.


