MODIFICATION OF PROMISSORY NOTE AND DEED OF TRUST

THIS MODIFICATION OF PROMISSORY NOTE AND DEED OF TRUST (the "Modification") is made by and between TRENT INVESTMENTS, LLC, an Oregon Limited Liability Company, and TEDDY B. WILLIAMS. The effective date of this Modification (the "Effective Date") shall be the last date of the signature executed below by either party.

RECITALS

WHEREAS, on November 13, 2008, Teddy B. Williams executed a Promissory Note in the sum of \$60,500 United States Dollars in favor of Trent Investments, LLC (the "Note");

WHEREAS, the principal balance plus all accrued interest owing on the Note was due on November 14, 2010, (the "Maturity Date"):

WHEREAS, contemporaneous with the execution of the Note, Teddy B. Williams executed a Trust Deed dated November 13, 2008, in favor of Trent Investments, LLC as Beneficiary, with First American Title Insurance Company of Oregon as Trustee, (the "Trust Deed"), to secure payment of the Note:

Williams shall reimburse and pay Trent Investments, LLC, costs, expenses and attorney's fees incurred by Trent Investments, LLC, concerning the preparation of this Modification and recording of the same contemporaneous with the execution of this Modification and prior to recording of the same;
- 3. All other terms and conditions of the Note and Trust Deed remain the same and in full force and effect;
- 4. In the case of any discrepancy, ambiguity or contradiction between and terms of the Note and Trust Deed and this Modification, the terms of this Modification shall supersede and control;
- 5. This Modification shall serve as an amendment to any escrow instructions executed by the parties and to any account servicing agent; however, the parties shall execute any documents necessary and/or required to carry out the intent of this Modification;
