## RESTRICTIVE COVENANT

Know all men by these presents that Klamath Health Partnership, Inc., an Oregon corporation, being the owner of Lots 1, 2, 3, 19 and 20, Block 206 of Mills 2<sup>nd</sup> Addition to the City of Klamath Falls, Oregon, and Lots 1, 2, 8, 9, 10, 11, 12 and 13, Block 205 Mills 2<sup>nd</sup> Addition to the City of Klamath Falls, Oregon (hereinafter known singly as "Lot" and collectively as "Lots"), for valuable consideration, grants a Restrictive Covenant (hereinafter referred to as "Covenant") prohibiting the transfer of any Lot that does not constitute a transfer of all Lots as a single unit.
