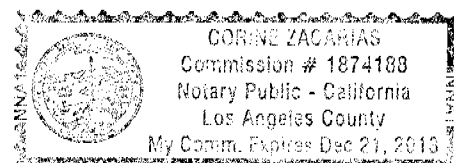

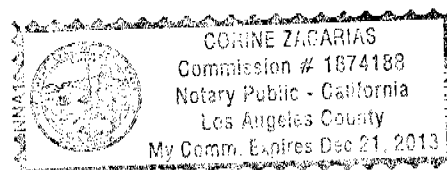

### **NOTICE TO RESIDENTIAL TENANTS**

The property in which you are living is in foreclosure. A foreclosure sale is scheduled for 11/12/2010. Unless the lender who is foreclosing on this property is paid, the foreclosure will go through and someone new will own this property. 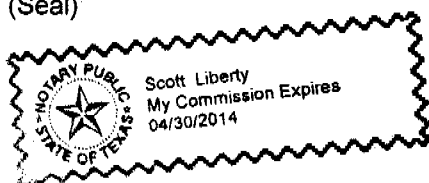

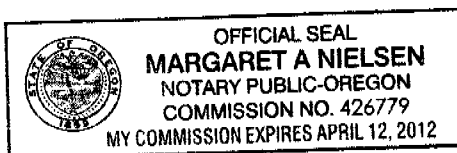

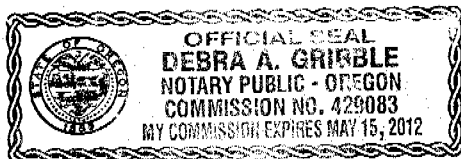
