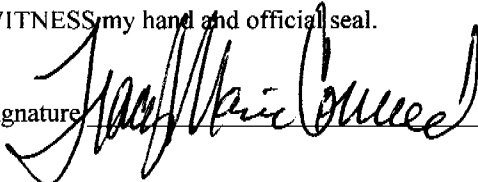

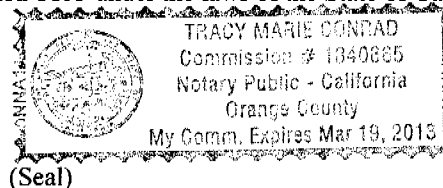

NOTICE TO TENANTS
