Judd, recorded 11/05/2007 in the records of Klamath County, Oregon at 2007-018898. Reference is made to that certain trust deed made by Curtis R. Judd and Jennifer A. Judd, Grantor(s), to Amerititle, trustee, in favor of National City Mortgage, as beneficiary, recorded 12/13/2007, in the Records of Klamath County, Oregon as Instrument No. 2007-020908, which was subsequently assigned to Green Tree Servicing, LLC on March 26, 2010 under Instrument No. 2010-003728, and Katrina E. Glogowski being the successor trustee, covering the following described real property situated in the above-mentioned county and state, to wit: APN: R512270; Tract 58, Yalta Gardens, according to the official plat there of on the file -- See Exhibit A; Commonly known as 1840 Homedale Road, Klamath Falls, OR 97603. The undersigned hereby certified that no assignments of the trust deed by the trustee or by the beneficiary and no appointments of a successor trustee have been made, except as recorded in the records of the county or counties in which the above described real property is situated. Further, no action has been instituted to recover the debt, or any part thereof, now remaining secured by the trust deed, or, if such action has been instituted, such action has been dismissed except as permitted by ORS 86.735(4). Both the beneficiary and the trustee have elected to sell the said real property to satisfy the obligations secured by said trust deed and notice has been recorded pursuant to section 86.753(3) of Oregon Revised Statutes. By reason of said default the beneficiary has declared all obligations secured by said deed of trust immediately due and payable, said sums being the following, to wit: The sum of \$182243.28 together with interest thereon at the rate of 7.055% per annum from Jan, 2010 until paid; plus advances of \$0.00; together with title expenses, costs, trustee's fees and attorneys' fees incurred herein by reason of said default; any further sums advanced by the beneficiary for the protection of the above described real property and its interest therein; and prepayment penalties/premiums, if applicable. 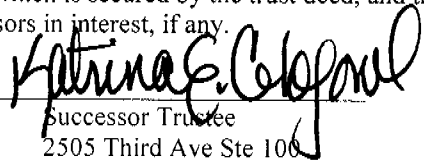

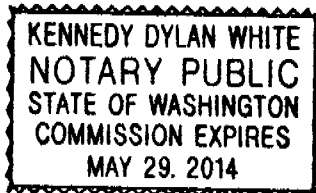

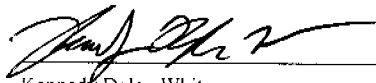
