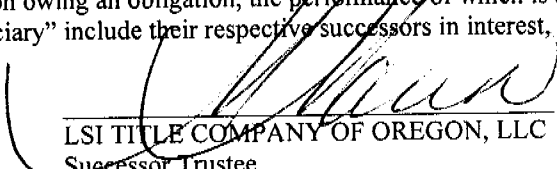

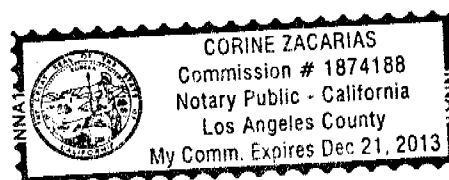

LEGAL DESCRIPTION
