NOTICE TO RESIDENTIAL TENANTS

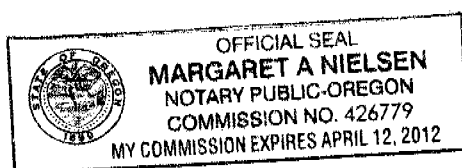



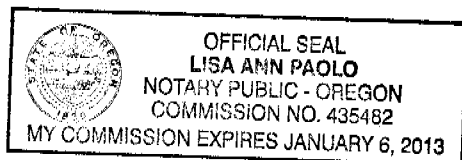
