NOTICE OF DEFAULT AND ELECTION TO SELL

Reference is made to that certain trust deed made by Stephanie L. 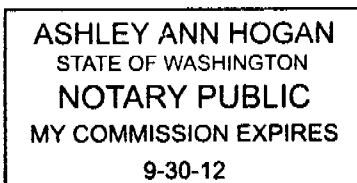
