TRUSTEE'S DEED UPON SALE

THIS INDENTURE, Made 2/24/2011, between FIRST AMERICAN TITLE INSURANCE COMPANY

Hereinafter called trustee, and **Federal National Mortgage Association**, hereinafter called the second party:

WITNESSETH:

RECITALS: ANDREW CARNES, as grantor, executed and delivered to FIRST AMERICAN TITLE OF OREGON, for the benefit of MORTGAGE ELECTRONIC REGISTRATION SYSTEMS, INC., ("MERS"), AS NOMINEE FOR BCK CAPITAL INC., as beneficiary, a trust deed dated 10/29/2007, duly recorded on 11/2/2007, in the mortgage records of KLAMATH County, Oregon, in book number xxx, at page, xxx, , or as fee/ file/ instrument/ microfilm/ reception number 2007-018856. After recording the Notice of Default and at least 120 days before the date the property was sold, a copy of the Notice of Sale and a copy of the Danger Notice required by ORS 86.737 were served by **FIRST AMERICAN TITLE INSURANCE COMPANY** pursuant to ORCP 7D (2) and 7D (3) or mailed by both first class and certified mail with return receipt requested to the last known address of all required/interested parties in ORS 86.740. The undersigned trustee has no actual notice of any person,

other than the persons named in said affidavits and proofs as having or claiming a lien on-or interest in said described real property, entitled to notice pursuant to ORS86.740. The Notice of Sale was served upon the occupant of the property described in the trust deed pursuant to ORS 86.750(1). Pursuant to ORS 86.755(9), if the foreclosure proceedings were stayed and released from the stay, copies of an amended notice of sale were mailed by registered or certified mail to the last-known address of the persons listed in ORS 86.740 and 86.750(1), and all other persons required to receive the notice.
