KNOW BY ALL THESE PRESENTS that I, **Sandra Jean Conner**,

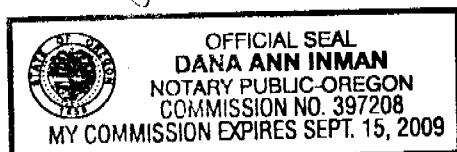
