MODIFICATION. Grantor(s) and Lender hereby modify the Note and Deed of Trust as follows:

[X] Maturity Date: the maturity date is extended to December 1st, 2034

[X] Payment Schedule. The payment schedule is revised as follows:

- (a) Borrower may skip payment due as of March 1st, 2011 and April 1st, 2011. Interest continues to accrue while payment is skipped. Borrower acknowledges that this will increase the amount of interest paid on the loan.
- (b) Borrower will make payments beginning May 1st, 2011.
- (c) On December 1st, 2034, Borrower will repay any remaining amounts due.

CONTINUING VALIDITY. Except as previously modified above, the terms of the original Deed of Trust and Note shall remain unchanged and in full force and effect. Consent by Lender to this Modification does not waive Lender's right to require strict performance of the Deed of Trust and the Note as changed above nor obligate Lender to make any future modifications. Nothing in this Modification shall constitute a satisfaction of the Note. It is the intention of Lender to retain as liable all parties to the Deed of Trust and all parties, makers, and endorsers to the Note, including accommodation parties, unless a party is expressly released by Lender in writing. Any maker or endorser, including accommodation makers, shall not be released by virtue of this Modification.
