NOTICE OF DEFAULT AND ELECTION TO SELL

Reference is made to that certain trust deed made by Jeffrey H Sargo and Annette B Sargo, Trustees of The Sargo 2001 Revocable, dated July 3, 2001, as grantors, to Chicago Title Insurance Company of Oregon, as trustee, in favor of Washington Federal Savings, as beneficiary, dated 01/22/07, recorded 01/31/07, in the mortgage records of Klamath County, Oregon, as 2007-001743, covering the following described real property situated in said county and state, to wit:

Due to potential conflicts with federal law, persons having no record legal or equitable interest in the subject property will only receive information concerning the lender's estimated or actual bid. Notice is further given that any person named in ORS 86.753 has the right, at any time prior to five days before the date last set for the sale, to have this foreclosure proceeding dismissed and the trust deed reinstated by payment to the beneficiary of the entire amount then due (other than such portion of the principal as would not then be due had no default occurred) and by curing every other default complained of herein by tendering the performance required under the obligation or trust deed, in addition to paying said sums or tendering the performance necessary to cure the default, by paying all costs and expenses actually incurred in enforcing the obligation and trust deed, together with trustee's and attorney's fees not exceeding the amounts provided by said ORS 86.753. 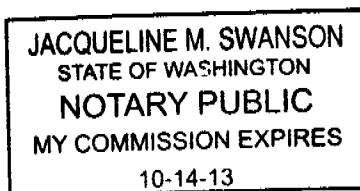
