RESTRICTIVE COVENANT **Accessory Structure Building Permit**

R-3612-01B0-04900

R-3612-001B0-05000

The undersigned, being the record owners of all of the real property described as follows; R-3612-001B0-05100, and further identified by "Exhibit A" attached hereto, do hereby make the following restrictive covenant(s) for the above-described real property, specifying that the covenant(s) shall run with the land and shall be binding on all persons claiming under such land, and that these restrictions shall be for the benefit of and limitation on all future owners of said real property.

The following restrictive covenant(s) hereafter bind the subject property:

"The 24 foot by 38 foot (912 square feet total) accessory structure described as a Storage shed and located on property designated by the Klamath County Assessor's Office as Tax Lot 5100 in Township 36 South, Range 12E East, Section 1B is permitted in conjunction with a primary use (Dwelling) on the adjacent parcel described as Tax Lot 5000 in Township 36 South, Range 12 East, Section 1B. Said structure may be used for purposes customarily accessory and subordinate to the primary use of the above referenced parcel."

"Tax lots 5100 and 5000, as described above, shall not be transferred, conveyed, leased, mortgaged or otherwise liened separately from each other but only to identical transferees, mortgagees or lien claimants until such time as a lawful primary use is permitted on Tax Lot 5100, where the named accessory use is located."

The covenant(s) shall not be modified or terminated except by the express written consent of the owners of the land at the time, and the Klamath County Community Development Department, as hereafter provided.

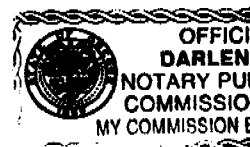
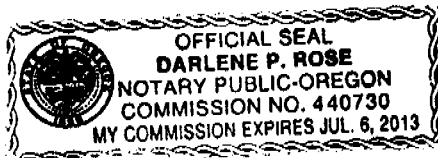
