That portion of the East 330 feet of Government Lot 2 that lies Northeasterly of Sprague River Highway, and the East 330 feet of the South one-half of Government Lot 1 in Section 19, Township 35 South, Range 10 East of the Willamette Meridian, Klamath County, Oregon.

The liability and obligations of the Grantor to Grantee and Grantee's heirs and assigns under the warranties and covenants contained herein or provided by law shall be limited to the extent of coverage that would be available to Grantor under any policy of title insurance issued to the Grantor at the time Grantor acquired the property.
