## **NOTICE TO RESIDENTIAL TENANTS**

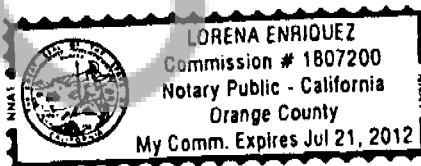

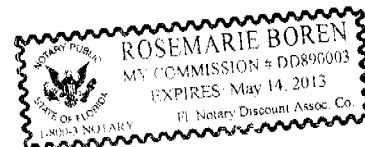

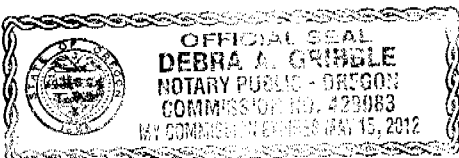
