TRUSTEE'S DEED

THIS INDENTURE, made July 28, 2011, between Northwest Trustee Services, Inc., hereinafter called the Trustee and Federal National Mortgage Association, hereinafter called the second party;

RECITALS: David B. Kent, as grantors, executed and delivered to: Aspen Title & Escrow, as trustee, for the benefit of Mortgage Electronic Registration Systems, Inc. solely as nominee for Gateway Financial Services, its successors and assigns, as beneficiary, a trust deed dated 10/21/04, duly recorded on 10/26/04 in the mortgage records of Klamath County, Oregon in Vol M04 Page 72965 and subsequently assigned to The Huntingon National Bank by Assignment recorded as 2011-003874.
