#### MEMORANDUM OF LEASE

THIS MEMORANDUM OF LEASE is made and entered into by and between Bly Water District, an Oregon municipal corporation, having an address at 61138 Highway 140 East, Bly, Oregon 97622, hereinafter referred to as "Landlord," and United States Cellular Operating Company of Medford, a Oregon Corporation, whose address is Attention: Real Estate, 8410 West Bryn Mawr Avenue, Suite 700, Chicago, Illinois, 60631, hereinafter referred to as "Tenant."

### WITNESSETH:

WHEREAS, the Landlord and the Tenant desire to execute this Memorandum of Lease to evidence said Lease and certain of the terms therein for the purpose of placing the same of record in the Clerk's Office for Kalamath County, State of Oregon.

NOW THEREFORE, in consideration of the sum of Ten (\$10.00) Dollars and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Landlord does hereby grant Tenant the option to lease the Premises and obtain certain easements upon the terms and conditions of the Lease which is incorporated herein by specific reference, and do agree as follows:

- 1. The Lease gives Tenant the option to lease the Premises, exercisable at Tenant's sole discretion, for a period of eighteen (18) months commencing on the \_\_\_\_\_\_ day of \_\_\_\_\_\_\_, 2011. Tenant may, at its sole discretion, extend the option term for an additional six (6) months.
- 2. In the event Tenant exercises the option to lease the Premises, in its sole discretion, then the Landlord shall lease the Premises to the Tenant for an initial lease term of five (5) years commencing on the date that Tenant begins construction. The Lease provides for renewal terms that may extend the term of the lease for up to five (5) additional five (5) year terms which may be exercised upon the terms and conditions more particularly as set forth in the Lease.
- 3. If Tenant exercises the option to lease the Premises, then Landlord also makes certain grants of easement for access and utilities, as more particularly described on the attached Exhibit A, which easements are in effect throughout the term of the Lease as renewed or extended, subject to terms and conditions as set forth in the Lease.
- 4. The Lease gives the Tenant the Right of First Refusal and option to purchase the Premises in the event of a transaction in which an unrelated third party submits an offer involving the transfer of all or any part of the Premises.
- 5. This Memorandum of Leases is subject to all the terms and provisions of the Lease which is incorporated herein and made part hereof by reference as if all the provisions thereof were copied in full herein. Any conflict between the provisions of the Memorandum of Lease will be resolved in favor of the Lease.

Containing 10,000 square feet of land, more or less.


