KNOW ALL BY THESE PRESENTS that *Elizabeth Dare and Dana L. Eckard, as tenants by the entirety,*

hereinafter called grantor, for the consideration hereinafter stated, does hereby grant, bargain, sell and convey unto *Elizabeth Dare as Trustee of the Elizabeth Dare Trust dated March 24, 2011 and Dana Eckard, as trustee of the Dana Eckard Trust dated March 24, 2011,* hereinafter called grantee, and unto grantee's heirs, successors and assigns, all of that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or in any way appertaining, situated in *Klamath* County, State of Oregon, described as follows, to-wit:

Lot 5 in Block 85, Klamath Addition to the City of Klamath Falls, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon.

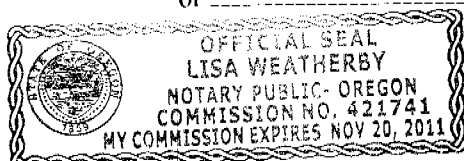
