Addendum to Vol. M02, Page 69231-69246, Section 6.0; also known as Non Exclusive Reciprocal Easement Agreement, in accordance with use and maintenance of two wells referenced in said document are now amended as follows:

- 1. All rights, easements, cost and responsibilities addressed in Original Agreement will remain intact as specified in that agreement except as noted in this document.
- 2. The well located on Parcel "A" (large well) will supply the three individual parcels.
- 3. The well located on Parcel "B" (small well) will serve as a back-up water supply to large well located on Parcel "A".
- 4. No more than a total of three (3) residences will be allowed on both wells.
- 5. The maintenance agreement is amended to split any maintenance associated with either well 1/3 to each party.
- 6. Electrical costs to operate both wells will be split 1/3 to each party.
- 7. A new well pump to the large well located on Parcel "A" was replaced in July, 2011 and replacement costs were shared 1/3 to each party.
