## MEMORANDUM OF LEASE

THIS MEMORANDUM OF LEASE is made and entered into by and between Angel Mt., LLC, a Oregon limited liability company, whose address is P.O. Box 1374, Klamath Falls, Oregon 97601, hereinafter referred to as "Landlord", and United States Cellular Operating Company of Medford, an Oregon corporation, whose address is Attention: Real Estate, 8410 West Bryn Mawr Avenue, Suite 700, Chicago, Illinois, 60631, hereinafter referred to as "Tenant."

WHEREAS, the Landlord and the Tenant desire to execute this Memorandum of Lease to evidence said Lease and certain of the terms therein for the purpose of placing the same of record in the Clerk's Office for Klamath County, State of Oregon

NOW THEREFORE, in consideration of the sum of Ten (\$10.00) Dollars and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Landlord does hereby lease to Tenant the Premises and grants certain easements upon the terms and conditions of the Lease which is incorporated herein by specific reference, and do agree as follows:

- 1. Landlord and Tenant have entered into a previous lease that commenced on March 26, 1997 and will expire on October 31, 2011. The parties entered into the aforementioned Lease to continue their relationship.
- 2. The Lease will commence on November 1, 2011 and will run for an initial lease term of five (5) years. The Lease provides for five (5) successive five (5) year renewal terms upon the terms and conditions more particularly as set forth in the Lease.
- 3. Landlord also makes certain grants of easement for access and utilities which easements are in effect throughout the term of the Lease as renewed or extended, subject to terms and conditions as set forth in the Lease.
- 4. This Memorandum of Leases is subject to all terms and provisions of the Lease which is incorporated herein and made part hereof by reference as if all the provisions thereof were copied in full herein. Any conflict between the provisions of the Memorandum of Lease will be resolved in favor of the Lease.
