The "Collateral" covered by this financing statement includes the following described property, whether now owned or hereafter acquired, whether now existing or hereafter arising, and wherever located, in which Debtor is giving to Secured Party a security interest for the payment of the Indebtedness and performance of all other obligations under the note, the security agreement, and the other loan documents between Debtor and Secured Party.

The eligible photovoltaic (solar) system under Oregon Administrative Rule 860-084-120 located and permanently installed at D7961 Reeder Road 50 Hp, Klamath Falls, Oregon, 97603, ("Equipment") and all accounts, contract rights, general intangibles, documents, instruments and chattel paper that arise from or relate in any way to the Equipment, and all identifiable cash proceeds from the disposition of any Equipment, including Debtor's rights under the Volumetric Incentive Rate Payment and Interconnection Agreement between Debtor and its electricity provider, including all net volumetric incentive rate payments.
