EXHIBIT "A" LEGAL DESCRIPTION

PARCEL 1:

A tract of land situated in the East 1/2 of the Northeast 1/4 of Section 13, Township 39 South, Range 9 East of the Willamette Meridian, Klamath County, Oregon, more particularly described as follows:

Beginning at a point located West a distance of 30 feet and South a distance of 1096.66 feet from the Northeast corner of said Section 13, said point being on the West boundary of the Klamath Falls-Merrill Highway; thence South along the West boundary of said highway a distance of 109.00 feet to a one-half inch iron pin and the true point of beginning; thence continuing South at the West boundary of said highway 40.14 feet; thence West to a point on the East bank of the Irrigation Lateral; thence Northwest along said bank to a point on the East bank of the Enterprise Irrigation Canal; said point being West a distance of 174 feet from the point of beginning; thence East 174 feet to the point of beginning.
