AMENDMENT NO. 15 TO RIGHT-OF-WAY AGREEMENT NO. M/L-690 OR-058508FD AND O&C LOGGING ROAD RIGHT-OF-WAY PERMIT NO. M/L-690 OR-058508FD

Agreement between the **UNITED STATES OF AMERICA**, acting through its agency, the Bureau of Land Management, hereinafter referred to as BLM, and **JWTR**, **OREGON**, **LLC**, an Oregon limited liability company, hereinafter referred to as JWTR. The terms and conditions of this amendment only apply to the roads and lands in Schedule 2b of the Agreement Area.

WITNESSETH:

WHEREAS, on June 19, 1963, WEYERHAEUSER COMPANY a Washington corporation (hereafter called Weyerhaeuser) granted to the UNITED STATES a Right-of-Way and Road Use Agreement No. L/M-690, which was accepted by the United States on June 19, 1963, and subsequently recorded in Volume 547, Page 588 in the Deed Records of Jackson County, Oregon, on June 19, 1963, and in Volume 346, Page 367 and in the Deed Records of Klamath County, Oregon, on July 8, 1963, said agreement granted for the purpose of management and removal of timber and other forest products from lands of the United States; and

WHEREAS, on June 19, 1963, the United States, Bureau of Land Management (hereafter referred to as the BLM), granted to Weyerhaeuser, O&C Logging Road Right-of-Way Permit, No. L/M-690, for the purpose of management and removal of timber and other forest products from land owned or controlled by Weyerhaeuser, as of time of exercise by Permittee of the rights granted by the government; and

WHEREAS, said permit and agreement were amended twelve (12) times with amendment #12 being approved on December 23, 1988 and recorded on December 23, 1988 in Volume M88 Page 21974 in the Official Records of Jackson County; and

WHEREAS, on August 27, 1996 Weyerhaeuser conveyed to U.S. TIMBERLANDS KLAMATH FALLS, LLC, a Delaware corporation, certain properties that were the subject of said Permit; and

WHEREAS, said Permit was transferred by a full assignment from Weyerhaeuser to U.S. TIMBERLANDS KLAMATH FALLS, LLC and approved by the United States on February 10, 1997; and

WHEREAS, on December 22, 2003, U.S. TIMBERLANDS KLAMATH FALLS, LLC changed their name by Certificate of Registration to INLAND FIBER GROUP, LLC, a Delaware corporation and the UNITED STATES recognized the name change and designated INLAND FIBER GROUP, LLC as the Permittee for said permit L/M-690; and

WHEREAS, said permit and agreement were subsequently amended by two (2) amendments (Nos. 13 and 14), with Amendment No. 14 being approved on March 30, 2006 and recorded on June 13, 2006 as document No. 2006-030071 in the Official Records of Jackson County; and

WHEREAS, on November 30, 2006, all of the lands served by said Permit L/M-690 which were owned by INLAND FIBER GROUP, LLC were conveyed jointly to JWTR, LLC, an Oregon Limited Liability Company and JELD-WEN, INC., an Oregon corporation; and

WHEREAS, on June 29, 2007, JELD-WEN, INC. conveyed their joint ownership of said lands to JWTR, LLC; and

WHEREAS, JWTR, LLC subsequently filed for and received a full assignment of rights in said Permit L/M-690, such assignment being approved by the UNITED STATES on October 11, 2007; and

WHEREAS, on March 4, 2010, JWTR, LLC changed their name by Certificate of Registration to JWTR Oregon, LLC, an Oregon limited liability company and the UNITED STATES recognized the name change and designated JWTR Oregon, LLC as the Permittee for said permit L/M-690; and

NOW, THEREFORE, the parties do mutually agree as follows: The previously omitted and the newly acquired PERMITTEE lands shown on Schedule 2b, attached hereto and made a part of Exhibit C-1 should be and are hereby added to Schedule 2b, of the said Agreement and Permit under the same terms and conditions and duration as the said permit and Agreement.

THAT IN ALL OTHER RESPECTS said Right-of-Way and Road Use Agreement No. L/M-690 and O&C Logging Road Right-of-Way Permit No. L/M-690 shall continue and remain in full force and effect.


