QUITCLAIM DEED

KNOW ALL BY THESE PRESENTS that Charles E Hull

hereinafter called grantor, for the consideration hereinafter stated, does hereby remise, release and forever quitclaim unto

hereinafter called grantee, and unto grantee's heirs, successors and assigns, all of the grantor's right, title and interest in that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or in any way appertaining, situated in Klamath County, State of Oregon, described as follows, to-wit:

Beginning at a point 1435.5 feet North and 720 feet East of an iron pin driven into the ground at the southwest corner of the Otis V. Saylor property near the southwest corner of the northwest quarter of Section 1, Twp. 39 S. R. 9 E. W. M., and which pin is 30 feet East of the center of a road intersecting the Klamath Falls-Lakeview Highway from the North and 30 feet North of the center of said highway; thence East 270 feet; thence North 321 feet; thence West 270 feet; thence South 321 feet to the place of beginning, containing two acres, more or less.

Subject to contract and/or lien for irrigation and/or drainage, and to reservations, easements and rights of way of record and those apparent on the land.

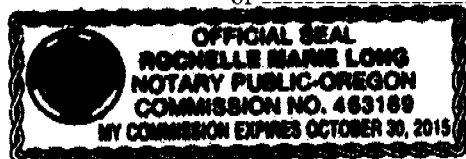
