You may do this only for the rent you owe your current landlord. If you do this, you must do so before the foreclosure sale. ABOUT YOUR TENANCY AFTER THE FORECLOSURE SALE

The business or individual who buys this property at the foreclosure sale may be willing to allow you to stay as a tenant instead of requiring you to move out.
