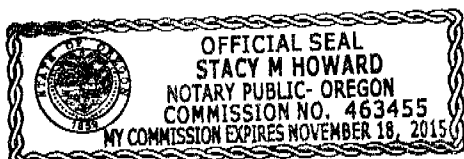

EXHIBIT "A" LEGAL DESCRIPTION

Lot 16 in Block 3 of WOODLAND PARK, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon.
