## RECITALS

The City of Klamath Falls, Oregon, a municipal corporation, ("City") on December 10, 2008 granted to Walter & Sara Seput (collectively referred to as "Grantee") non-exclusive permission to encroach upon a portion of the Damont and Auburn Streets rights-of-way in the City of Klamath Falls for the proposes of constructing a driveway and a retaining wall.

In order to document this permission, City and Grantee executed a "Revocable License and Encroachment Permit" ("Encroachment Permit"), which was recorded in the records of Klamath County at 2008-016851 on December 29, 2008.

Grantee is in the process of improving their driveway and property with a snowmelt system and Grantee and City have agreed that the previously referenced Encroachment Permit is no longer needed for just those two purposes, but for multiple purposes. Both parties prefer to have one document reflecting the encroachment needs.
