KNOW ALL BY THESE PRESENTS that I, Thomas Robert Krobusek

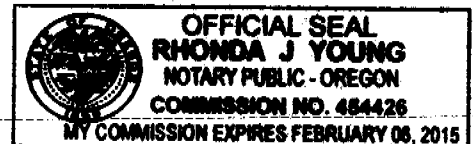
have made, constituted and appointed, and by these presents do hereby make, constitute and appoint Diane

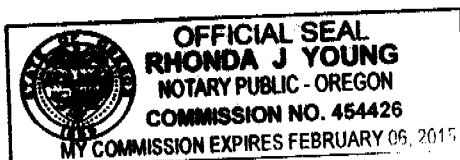
