Description: Real property in the County of Klamath, State of Oregon, described as follows: Parcel 1: The Northerly 60 feet and the Westerly 150 feet of the Southerly 85.44 feet of Lot E, Subdivision of Enterprise Tract No. 24 in the NW 1/4 of Section 3, Township 39 South, Range 9 East of the Willamette Meridian, Klamath County, Oregon. Parcel 2: Starting at the Northwest corner of Section 3, Township 39 South, Range 9 E, W.M., Oregon; thence S. 00°00' 1/2' E. along the Westerly boundary of said Section 3, 826.8 feet, more or less, to its intersection with a line parallel with and 75 feet distant at right angles Northeasterly from the center line of the Klamath Falls-Lakeview State Highway, also known as South Sixth Street, as the same is now located and constructed, said parallel line being also the Northerly right of way line of said highway; thence S. 55° 52' 1/2' E. along said right of way line 2192.4 feet, more or less, to an iron peg marking the Southwesterly corner of that certain tract of land conveyed to Swan Lake Moulding Company by deed dated May 16, 1968 and recorded in Volume M68 page 4736 of Klamath County Deed records from which peg a cross chiseled in the concrete sidewalk bears S. 34° 07' 1/2' W. 10.0 feet; thence N. 34° 07' 1/2' E. at right angles to Sixth Street 150.0 feet to an iron peg and the true beginning point of this description; thence S. 55° 52' 1/2' E. 73.52 feet to an Iron peg in the East line of Enterprise Tracts No. 33A; thence N. 00° 21' 1/2' E. 132.36 feet along said East line to an Iron peg; thence S. 34° 07' 1/2' W. 109.92 feet to the place of beginning, Tax Parcel Number: 579742
