EXCEPTING THEREFROM that portion deeded to Klamath County in Book 335 page 87, and parcel deeded to United States of America for canals and laterals recorded June 25, 1909 in Book 27 page 236 and in Book 38 pages 209 and 210, all Deed records of Klamath County, Oregon, and that portion of Tract 40C described as follows:

Beginning at a one-half inch iron pin on the East right of way line of Washburn Way, said point being North 00°20'00" East along the centerline of Washburn Way and along the West line of Section 34 a distance of 332.19 feet and South 89°33'03" East a distance of 30.00 feet from the 5/8 inch iron pin marking the West one-quarter corner of Section 34; thence North 00°20'00" East along the East right of way line of Washburn Way a distance of 285.00 feet to a one-half inch iron pin; thence South 89°33'03" East parallel with the North line of "Mills Gardens" subdivision a distance of 472.43 feet to a one-half inch iron pin; thence continuing South 89°33'03" East a distance of 29 feet more or less, to the Westerly right of way line of the U. S. B. R.
