EXHIBIT "A" LEGAL DESCRIPTION

A parcel of land situated in Section 31, Township 34 South, Range 7 East of the Willamette Meridian, Klamath County, State of Oregon, being more particularly described as follows:

Beginning at a 5/8 inch iron pin on the South line of the NW1/4 of said Section 31, from which an axle marking the Southeast corner of said NW1/4 bears South 89°39'59" East along said South line, 57.66 feet; thence North 04°45'10" West, 649.89 feet; thence South 89°48'20" East parallel to but 660 feet Southerly of the North line of the SW1/4 NE1/4 of said Section 31, 777.50 feet to the Westerly right of way line of Oregon Highway No. 62; thence South 11°51'08" East along said right of way line, 664.18 feet to the intersection of said right of way line with the South line of the N1/2 of said Section 31; thence leaving said right of way line North 89°39'59" West along said South line of the N1/2 of Section 31, 860.08 feet to the point of beginning.
