A PORTION OF LOT 19, TOWNSEND TRACTS, IN THE COUNTY OF KLAMATH, STATE OF OREGON, BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

BEGINNING ON THE SOUTH LINE OF TRACT 19, TOWNSEND TRACTS, AT A POINT THEREON DISTANT 50 FEET EAST OF THE SOUTHWEST CORNER OF SAID TRACT; THENCE EAST ALONG SAID SOUTH LINE 50 FEET; THENCE NORTH AND PARALLEL TO THE EAST LINE OF SAID TRACT 145 FEET TO THE NORTH LINE OF SAID TRACT; THENCE WEST ON THE NORTH LINE 50 FEET; THENCE SOUTH AND PARALLEL TO SAID EAST LINE TO TRACT, 145 FEET TO THE PLACE OF BEGINNING.

Hereby grants, assigns, transfers, and sets over to: **Andrea S. Shapiro IRA, South Valley Bank & Trust, an Oregon Banking corporation, its successors and assigns, custodian**

Hereinafter called assignee, and assignee's heirs, personal representatives, successors and assigns all of the beneficial interest in and under the trust deed, together with the notes, moneys and obligations therein described or referred to, with the interest thereon, and all rights and benefits whatsoever accrued or to accrue under the trust deed.

The undersigned hereby covenants to and with the assignee that the undersigned is the beneficiary or beneficiary's successor in interest under the trust deed and is the owner and holder of the beneficial interest therein and has the right to sell, transfer and assign the same, and the note or other obligation secured thereby. In construing this instrument and whenever the context so requires, the singular includes the plural. IN WITNESS WHEREOF, the undersigned has hereunto executed this document.

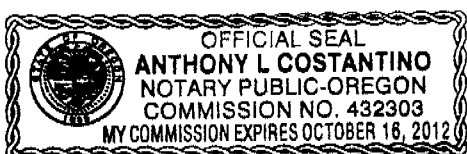
