WHEREAS, on April 30, 2012, the County Planning Director filed a written report finding that vacating the interior lot lines of the property described in Exhibit "A", attached hereto and incorporated herein, complies with all applicable land use regulations, would not be detrimental to the public interest and would facilitate future development of the property; and

WHEREAS, after fully considering the report and other documentation presented, the Board of County Commissioners finds that the vacation of the lot lines between Lots 14 and 15 Block 29 of Klamath Forests Estates, 1st addition, (Lot #14 MAP R3510-021D0-02600-000 and Lot #15 R3510-021D0-02700-000) located in Klamath County, Oregon described in Exhibit "A", finds that the petition should be granted, and it should be noted that this property is already on the tax roll.

NOW, THEREFORE IT IS HEREBY ORDERED that the petition is granted and that the lot lines and utility easements described herein are vacated; and

IT IS FURTHER ORDERED that the fees resulting from the approved vacation are determined to be \$150.00, which the petitioner submitted payment of \$150.00 on January 19, 2012.

Request from Judy L. Erickson to vacate the lot line between lots 14 and 15 of Block 29.

Klamath Forest Estates, 1st Addition (Map numbers R-3510-021D0-02600 & 2700).

ORS Chapter 368 provides as follows:

368.351 Vacation without hearing. A county governing body may make a determination about a vacation of property under ORS 368.326 to 368.366 without complying with ORS 368.346 if the proceedings for vacation were initiated by a petition under ORS 368.341 that indicates the owners' approval of the proposed vacation and that contains the acknowledged signatures of owners of 100 percent of private property proposed to be vacated and acknowledged signatures of owners of 100 percent of property abutting public property proposed to be vacated and either:... or

(2) The planning director of the county files a written report with the county governing body in which the planning director, upon review, finds that an interior lot line vacation affecting private property complies with applicable land use regulations and facilitates development of the property subject to interior lot line vacation.

The purpose of the above referenced interior lot line vacation request is to remove interior lot lines established by Klamath Forest Estates Subdivision, situated in Section 21, Township 35 South, Range 10 East Willamette Meridian (see attached map). The two existing lots are 2.37 (TL 2600) and 2.97 (TL 2700) acres in size and are zoned R-2 (Rural Residential – 2 acre minimum lot size). Once the interior lot lines are vacated, they will become one unit of land 5.34 acres in size.

I find that vacating the interior lot lines of the above referenced private property complies with all applicable land use regulations, is not detrimental to the public interest, and facilitates development of the property.
